DECREE

COMES NOW Hattie L. Johnson, petitioner herein, by John S. Mackey, her attorney, and proves to the satisfaction of the Court that she filed her petition herein on the 9th day of May, 1961 for a decree of this Court establishing the death of Frank Johnson, who was also known as Frank L. Johnson, and the time thereof, and determining his heirs at law, their degree of kinship and the right of descent of the real property of said decedent; and it appearing that the Clerk of this Court did set said petition for hearing and has given due and legal notice thereof as required by law, and said matter coming on now to be heard, the Court, after hearing the evidence does find that the allegations of the petition are true and that the prayer thereof should be granted, and now on the motion of John S. Mackey, petitioner's attorney, and no objections being made thereto;

IT IS ORDERED, ADJUDGED AND DECREED that Frank Johnson, also known as Frank L. Johnson, died intestate on the 16th day of January, 1956, leaving surviving him as his only heirs at law his widow, Hattie L. Johnson, and Chester L. Johnson, a son; and June Alexander, a daughter; and Vivian Shaul, a daughter; and Frankie Hawley, a daughter; that all of the real property of the said decedent described as follows:

Lots numbered 16, 17, 18, 19, 20, 22, 23, 24, 25, 26, 27 and 28, Block 5; and Lots numbered 20, 21, 25, 26 in Block 6; all in the Townsite of Shelter Park, Sublette County, Wyoming, together with the improvements and appurtenances situate thereon or appertaining thereto;

descended upon his death unto said heirs at law and vested in them in the following shares and estates:

Hattie L. Johnson, an undivided one-half part and interest in said lands; and unto each of the four children, Chester L. Johnson, a son; June Alexander, a daughter; Vivian Shaul, a daughter; and Frankie Hawley, a daughter, an undivided one-eighth part and interest in and to said lands.
