SUBORDINATION AGREEMENT

THIS AGREEMENT, made and entered into this 10th day of June, 1963, by and between Dorothy Eklund Anderson and Glenn S. Anderson, her husband, and Frederick Lawrence Eklund and Elaine Eklund, his wife, hereinafter referred to as FIRST PARTY and the Town of Pinedale hereinafter referred to as SECOND PARTY,

WITNESSETH

WHEREAS, FIRST PARTY is the owner of the oil, gas and other minerals in and to that certain tract of land situated in Sublette County, State of Wyoming, more particularly described as follows:

Lot 1, Section 31, Township 33 North, Range 108 West
NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 31, Township 33 North, Range 108 West
N $\frac{1}{4}$ Lot 2, Section 31, Township 33 North, Range 108 West
N $\frac{1}{4}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 31, Township 33 North, Range 108 West

WHEREAS, SECOND PARTY is the owner and operator of the Ralph Wenz Field, hereinafter referred to as the Airport, situated in the County of Sublette, State of Wyoming, in close proximity to said Parcel 2; and

WHEREAS, it is deemed necessary that all of Parcel 2 remain free and clear of any structures or other objects which is or would constitute an obstruction or hazard to the flight of aircraft in landing and taking-off at said Airport.
