That he is personally acquainted with Mildred M. Miller, who is a grantor with Robert L. Miller in that certain warranty deed which was executed and acknowledged February 2, 1961, and filed for record on February 14, 1961, in the office of the Clerk of Sublette County, Wyoming, and recorded in Book 10 of Deed Records in said office, at page 489; and the said Mildred M. Miller and Robert L. Miller did convey and warrant in said deed unto Big Piney Development, Inc., the following described real estate:

All of Block Two (2) of the Miller Addition as the same appears of record on the official plat thereof in the office of the County Clerk in and for Sublette County, Wyoming, which subdivision is part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 36, Township 30 North, Range 112 West of the Sixth Principal Meridian, Wyoming, excepting, excluding and reserving therefrom all minerals, oil, gas, petroleum and other hydro-carbon substances contained therein, together with the right to drill for, mine and remove the same only from points outside the boundaries of the above described subdivision.
