

CERTIFICATE OF CHANGE OF NAME

The undersigned W. Robert Dubois, President, and C. L. Bristol, Cashier of The First National Bank and Trust Company of Wyoming, a national banking corporation, do hereby certify that the name of this association was formerly "THE STOCK GROWERS NATIONAL BANK OF CHEYENNE, WYOMING," and that upon the 10th day of September, 1963, the stockholders of said The Stock Growers National Bank of Cheyenne, Wyoming adopted a resolution to change the name of said association to "THE FIRST NATIONAL BANK AND TRUST COMPANY OF WYOMING," and that pursuant to such resolution the Acting Comptroller of the Currency of the United States issued a certificate December 30, 1963, which is as follows:
