

CONSENT TO SUB-LEASE

William P. Dew of Pinedale, Wyoming, who is the Lessor named in that certain Ranch Lease Agreement dated the 1st day of November, 1955, made and entered into by and between the said William P. Dew, as Lessor, and Thomas G. Dew and Anna M. Dew, husband and wife, of Cora, Wyoming, Lessees, does hereby bind himself unto the aforesaid Lessees in the following manner;

WHEREAS the aforesaid lease agreement does demise and let and lease the lands hereinafter described, to-wit:

SW $\frac{1}{4}$ NE $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$, Section 11;
S $\frac{1}{2}$ SW $\frac{1}{4}$, Section 12;
W $\frac{1}{2}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$, Section 13;
NE $\frac{1}{4}$, NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 14;
Township 37 North, Range 110 West of the Sixth Principal Meridian, Wyoming, together with all buildings, fences, and improvements and all water and water rights, ditch and ditch rights situate thereon or appurtenant thereto,

for the term of twenty years, and in said agreement the Lessor has reserved the right to approve all agreements between the Lessees and sub-lessees;

NOW THEREFORE, in consideration of One Dollar and other good and valuable considerations, William P. Dew, the Lessor aforesaid, does hereby consent and agree that the aforesaid Lessees may sub-let the above described lands or any portion thereof to any person, or persons, of their choice from this day until the final termination of said lease agreement which is herein agreed to be the 31st day of October, 1975.

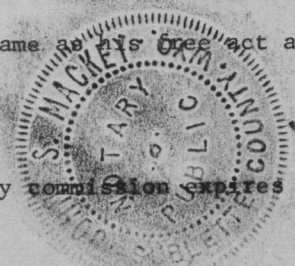
