FINANCIAL RESPONSIBILITY BOND

TO: The Superintendent, designated and duly authorized by the State Board of Equalization of the State of Wyoming and charged with the administration and enforcement of the Motor Vehicle Safety-Responsibility Act, and to all other persons who may be entitled to recover damages from ~~WARD DEWEY~~ <sup>*Duey*</sup> BLACKMON as the result of a certain automobile accident which occurred on the 28th day of August, 1964, in Sublette County, Wyoming, 1.2 miles north of the Daniel junction and in which Guffer Harrison, Ken Owen White, and Ward ~~Dewey~~ <sup>*Duey*</sup> Blackmon, among others, were involved:

KNOW ALL MEN BY THESE PRESENTS:

That ~~WARD DEWEY~~ <sup>*Duey*</sup> BLACKMON, as principal and as surety, and JESSIE C. BLACKMON, as surety, are held firmly bound and that the following described real property located in the State of Wyoming, to-wit:

Lot Four (4) Section (4); Lots One (1), Two (2), Three (3), Four (4), Southwest Quarter Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ ), South Half Northwest Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$ ), Northeast Quarter Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$ ), Northwest Quarter Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ ), Section Five (5); Township Thirty-four (34) North, Range One Hundred Eleven (111) West:: Southeast Quarter Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ ), Northeast Quarter Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ ), South Half Southeast Quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$ ), Section Thirty-two (32); West Half Southwest Quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$ ), Section Thirty-three (33); Township Thirty-five (35) North, Range One Hundred Eleven (111) West of the Sixth (6th) Principal Meridian, Wyoming

is held and firmly bound unto the State of Wyoming, and to such other persons as above described who are entitled to recover damages of and from said Ward ~~Dewey~~ <sup>*Duey*</sup> Blackmon as the result of the above described accident in the full and just sum of TWENTY-FOUR THOUSAND SEVEN HUNDRED NINETY-FIVE DOLLARS (\$24,795). Said Ward ~~Dewey~~ <sup>*Duey*</sup> Blackmon and Jessie C. Blackmon do as aforementioned bind themselves, the above described real property, their heirs, personal representatives, successors and assigns, jointly and severally, to pay the aforementioned sum of money unto the beneficiary or beneficiaries of these presents as described herein.

This bond is made and given in accordance with the provisions of the Wyoming Motor Vehicle Safety-Responsibility Act. The condition of this obligation as aforesaid is such that if the said principal shall satisfy in full any judgment or judgments which may be recovered against him for damages from the aforementioned motor vehicle accident, or otherwise become relieved of and from the suspension provisions contained in the Wyoming Motor Vehicle Safety-Responsibility Act, by compliance with the provisions contained therein, then these obligations and these presents shall
