

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED, that the said account of said administrator be, and the same is hereby settled, allowed and approved, and that the residue of said estate, hereinafter particularly described, and any other property not now known or discovered and which may belong to the said estate or decedent, or in which the said estate or decedent may have any interest, be, and the same is hereby distributed to V. J. Facinelli;

That the following is a particular description of the residue of said estate referred to in this decree, and of which distribution is now ordered, as aforesaid:

1. An undivided thirty per cent (30%) equitable interest in the assets of the LaBarge Livestock Company, said assets being more particularly described as follows:

- (a) Balance due on William Thoman contract amounting to \$62,000.00, together with interest thereon;

PETERSON PLACE: Lots Thirteen (13), Fourteen (14), Seventeen (17) and Eighteen (18) of Section Seventeen (17) in Township Twenty-three (23) North of Range One Hundred Eleven (111) West of the Sixth Principal Meridian, Wyoming, containing 176.40 acres.

VICKREY PLACE: Lots Eleven (11) and Fourteen (14) of Section Twenty-five (25) and the Lots Thirteen (13) and Fourteen (14) of Section Twenty-six (26) in Township Twenty-three (23) North of Range One Hundred Eleven (111) West of the Sixth Principal Meridian, Wyoming, containing 160.01 acres.
