RIGHT OF WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

THAT Floyd E. Bousman and Margaret J. Bousman,
 husband and wife,

of Sublette County, State of Wyoming, parties of the first part, for and in consideration of the sum of One (\$1.00) Dollar and other valuable considerations, receipt of which is hereby acknowledged, have granted and conveyed, and by these presents do grant and convey unto the Boulder Irrigation District, of Sublette County, Wyoming, party of the second part, its successors and assigns, an EASEMENT for a right of way to place, construct, operate, repair and maintain an irrigation ditch or canal and water transmission or distribution system with necessary appurtenances thereto, over, through, across and upon the following described property of the parties of the first part, located in Sublette County, State of Wyoming, described as follows, to-wit:

A tract of land one (100) feet on each side of a centerline of the Boulder Canal as set forth on a map or plat thereof, entitled Route of the Boulder Canal, Part II, Boulder Lake Watershed, as the same appears of record in the Office of the County Clerk and Ex-Officio Register of Deeds, Sublette County, Wyoming, covering the following described real property, to-wit:

Township 32 North, Range 108 West of the 6th P.M.
 Section 1 - SE $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 12- N $\frac{1}{2}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 13- SE $\frac{1}{4}$ NE $\frac{1}{4}$

Township 32, North Range 107 West of the 6th P.M.
 Section 7 - Lots 1 & 2 (W $\frac{1}{2}$ SW $\frac{1}{4}$)

Said parties of the first part, their heirs, legal representatives and assigns shall have full use and enjoyment of the said premises except for the uses and purposes hereinbefore granted. The said party of the second part shall have full right of ingress and egress to and from said described lands for the purpose of exercising the rights herein granted.

This grant of easement shall at all times be deemed to be, and shall be a continuing covenant running with the land and shall be binding upon the heirs, legal representatives and assigns of the parties of the first part.
