CERTIFICATE OF RELEASE OF LIEN

KNOW ALL MEN BY THESE PRESENTS that the undersigned, a duly authorized representative of the Sales and Use Tax Division of the Department of Revenue of the Board of Equalization of the State of Wyoming, does hereby certify and say:

1. THAT on the 9th day of October, 1964 at 9:00 A.M. the Sales and Use Tax Division of the Department of Revenue of the Board of Equalization of the State of Wyoming filed of record with the County Clerk of Sublette County, Wyoming, a Certificate of Lien, wherein the said division gave notice that it asserts and claims a lien under the provisions of Sections 39-286 through 39-335, Wyoming Statutes, 1957, upon all the real and personal property of every kind and description whatsoever owned by or to be acquired by Triangle R. Inc. Pinedale, Wyoming for sales tax, penalty and interest due and owing the said division in the amount of \$349.48.

2. THAT subsequent to the said filing of the Certificate of Lien above referred to, the said Triangle R. Inc., remitted in full to the above said Sales and Use Tax Division the sales tax, penalty and interest set forth in said Certificate as due and owing the said division.

3. THAT as a result of the above said remittance, the Sales and Use Tax Division of the Department of Revenue of the Board of Equalization of the State of Wyoming, now disclaims the lien described and set forth in the above Certificate of Lien and asserts that such lien has been released and discharged by operation of the provisions of Sections 39-286 through 39-335 of the Wyoming Statutes, 1957.

4. THAT the County Clerk of Sublette County, Wyoming is hereby authorized and empowered to note the foregoing disclaimer, release and discharge of lien upon the margin of the page of the book wherein the same is recorded in the Sublette County records.
