

NOTICE OF OIL AND GAS LIEN

COMES NOW H. S. LEWIS, JR., being of lawful age and first duly sworn, deposes and declares:


1. That he is Credit Manager of JOHNSTON TESTERS, a Division of Schlumberger Well Surveying Corporation, a Texas corporation, with a permit to do business in the State of Wyoming; that said Division, JOHNSTON TESTERS, hereinafter referred to as Claimant, has its principal place of business at Sugarland, Fort Bend County, Texas (P. O. Box 36369, Houston, Texas); and that he is duly qualified and authorized to make this Affidavit and Claim for and on its behalf.

2. That Claimant furnished to, and under contracts with SIMCO PETROLEUM CORPORATION, services and materials on the dates and as itemized for the constructing, altering, digging, drilling, boring, operating, completing and/or repairing of the oil and/or gas well, all as set forth in the instrument hereto attached, marked Exhibit "A" and made a part hereof; that same is a true and correct statement of the services and materials furnished by Claimant on the oil and/or gas well and for the purposes aforesaid; that all just and lawful payments, offsets and credits have been allowed and that there is justly due and owing by SIMCO PETROLEUM CORPORATION to Claimant therefor the principal sum of TWO THOUSAND FIVE HUNDRED EIGHTY AND 50/100 DOLLARS (\$2,580.50), plus interest thereon at the rate of six per cent (6%) per annum from thirty (30) days after the dates of the performance of the respective items of such account until paid and plus twenty per cent (20%) of such principal sum as contractual attorney's fees, if collected through legal proceedings or by an attorney.

3. That the oil, gas and mineral lease and leasehold estate upon which the said oil and/or gas well is located, and to which said services and materials were furnished, is comprised of land in Sublette County, State of Wyoming, and further described as follows:


Lots 1, 2, 3, 4, 5, 7 and 8 (being also described as the NE/4 and the NW/4 of the SE/4) of Section 23, Township 28 North, Range 112 West, containing approximately 200 acres in all, from the surface to a depth of 200 feet into the Mesaberde formation plus 50 feet.

WHEREFORE, to secure the aforementioned charges, JOHNSTON TESTERS, a Division of Schlumberger Well Surveying Corporation, has and claims a lien against the interest of SIMCO PETROLEUM CORPORATION from the date said services and materials were first furnished, in the oil and gas lease and leasehold aforesaid, the buildings and appurtenances thereto; in the oil and/or gas well for which the services and materials were furnished as aforesaid and in all other wells located upon such leasehold; in the oil and gas produced therefrom and the proceeds thereof inuring to the interest of SIMCO PETROLEUM CORPORATION; and in all material furnished to be used in connection with said improvement.
