KNOW ALL MEN BY THESE PRESENTS:

That the undersigned Tom Harrower also known as Thomas Harrower and Lillian Harrower (hereinafter called "Grantor"), for and in consideration of the sum of THREE HUNDRED NINETY AND NO/100 DOLLARS (\$390.00), in hand paid by SOCONY MOBIL OIL COMPANY, INC., the receipt of which is hereby acknowledged, does hereby grant and convey unto SOCONY MOBIL OIL COMPANY, INC., a New York corporation, with an office in Casper, Wyoming (hereinafter called "Grantee"), its successors and assigns, a right of way to construct, operate and maintain electric lines including, but not limited to, poles, wires, cables, conduits, anchors, stub poles, guy wires and other appurtenances used in connection therewith, together with the right to permit the attachment, maintenance and use of wires and cables of any other company and the right to trim any trees or other obstructions along said lines so as to keep the wires and cables cleared by at least eighteen inches and to alter, add to, change and remove said lines from time to time, along, under, through, upon, under and across that certain land situated in the County of Sublette, State of Wyoming, described as follows:

Township 27 North, Range 113 West, 6th. P.M.

Section 5: Lots 3, 4, SW $\frac{1}{4}$ NW $\frac{1}{4}$

6: Lots 1, 2, 3, 4, 5, SE $\frac{1}{4}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$

Township 27 North, Range 114 West, 6th. P.M.

Section 12: E $\frac{1}{2}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$

Together with right of ingress and egress to and from said right of way for the purposes aforesaid. Grantor reserves the right to use and fully enjoy the above described premises, except as to the rights hereinbefore granted.

All lines erected under this grant shall be erected upon a route selected by the Grantee, its successors or assigns.

As to the rights hereby granted, all rights under and by virtue of the homestead exemption laws of this state are hereby released and waived.

This agreement shall be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
