DECREE OF SETTLEMENT OF ACCOUNT AND FINAL DISTRIBUTION

Mason E. Phillips, administrator with the will annexed of the estate of Corydon Y. Phillips, deceased, having heretofore rendered and filed herein a full account and report of his administration of said estate, which account was for final distribution of said estate;

Said account and petition coming on this day regularly to be heard and proof having been made to the satisfaction of the Court that Notice of Settlement of said account and the hearing of said petition had been given in the manner and for the time as provided by the laws of the State of Wyoming;

And it appearing that said account is in all respects true and correct and no objections having been filed thereto, and it further appearing that all claims and debts against said decedent and taxes of said estate, and all debts, expenses and charges of administration have been fully paid and discharged, and that said estate is ready for distribution and in condition to be closed;

And it further appearing that said Corydon Y. Phillips died testate on the 24th day of October, 1929, in the County of Bannock, State of Idaho; and that under the terms and conditions of the Will of the said Corydon Y. Phillips, deceased, and probated herein, Mason E. Phillips, son, of Daniel, Wyoming, is entitled to an undivided three-fourths interest in and to the property hereinafter described; and that Mrs. Geraldine Burton, daughter, of Downey, Idaho, is entitled to an undivided one-fourth interest in and to the property hereinafter described.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the said final account of Mason E. Phillips, administrator with the will annexed, be and the same is hereby settled, allowed and approved; and that all the rest, residue and remainder of said estate now in existence or any other property not now known or discovered which may belong to said estate, or in which the said estate may have an interest, be and the same is hereby distributed as follows, to-wit:

An undivided three-fourths interest in the entire estate of Corydon Y. Phillips, deceased, real, personal and mixed, and wherever situate within the State of Wyoming, is hereby set over and absolutely vested in the said Mason E. Phillips; and an undivided one-fourth interest in the entire estate of Corydon Y. Phillips, deceased, real, personal and mixed, and wherever situate within the State of Wyoming, is hereby set over and absolutely vested in the said Mrs. Geraldine Burton, forever.
