

RIGHT OF WAY EASEMENT


Know All Men By These Presents:

That for and in consideration of the sum of one dollars, the receipt of which is hereby acknowledged and confessed, Richard L. Thomson and Mary E. Thomson, husband and wife,

of the County of Sublette and the State of Wyoming hereinafter called the grantor, hereby grants to the State of Wyoming, hereinafter called the grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sublette and State of Wyoming, to-wit:

The location, width of right of way hereby granted is as follows: A strip of land eighty feet in width being part of the $S\frac{1}{2}SW\frac{1}{4}$ and $NE\frac{1}{4}SW\frac{1}{4}$ of Section 20, T35N, R110W, Sublette County, Wyoming, with the center-line being described as follows: Beginning at Station 54+12.9 on the west line of said Section 20 N00°-03'W, 660.7 ft. from the southwest corner of said Section 20; thence N78°-26'E, 800.3 feet to Station 46+12.6; thence N57°-41'E, 1516.3 ft. to Station 30+96.3; thence N64°-37'E, 620 ft., more or less, to Station 24+76.3 on the east line of the said $NE\frac{1}{4}SW\frac{1}{4}$; and a strip of land eighty feet in width being part of the $S\frac{1}{2}SE\frac{1}{4}$ of Section 19 T 35N, R110W, Sublette County, Wyoming, with the center-line being described as follows: Beginning at Station 54+12.9 on the east line of said Section 19 N00°-03'W, 660.7 ft. from the southeast corner of said Section 19; thence S78°-26'W, 2700 ft., more or less, to Station 81+12.9 on the west line of the said $S\frac{1}{2}SE\frac{1}{4}$; all in accordance with the map prepared and filed for record in the Office of the Clerk of Sublette County, Wyoming.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to fence the right of way on both sides with wire fence with posts feet apart, with gates at such points as are necessary. Grantor to maintain fence thereafter.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irrigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

The grant herein contained is an easement and shall be perpetual so long as said land is used for the aforementioned purposes.
