Beginning at a point on the south 1/16 line of aforesaid Section 9 which point bears N.  $33^{\circ}04'$  W., more or less, a distance of 1,625.9 feet, more or less, from the southeast corner of aforesaid Section 9, said point of beginning is also the north end of Wyoming Game and Fish Commission road easement in SE $\frac{1}{4}$ SE $\frac{1}{4}$  aforesaid Section 9; thence N.  $22^{\circ}48'$  E., more or less, a distance of 530.0 feet, more or less; thence N.  $07^{\circ}03'$  E., more or less, a distance of 1,256.8 feet, more or less; thence N.  $25^{\circ}05'$  W., more or less, a distance of 999.2 feet, more or less, to a point on the N. 1/16 line of the aforesaid Section 9, which point is also the south end of a Wyoming Game and Fish Commission road easement in NE $\frac{1}{4}$ NE $\frac{1}{4}$  aforesaid Section 9. Beginning at a point on the E. 1/16 line of aforesaid Section 9, which point bears N.  $76^{\circ}42'$  W., more or less, a distance of 1,356.5 feet, more or less, from the southeast corner of aforesaid Section 9, which point is also the west end of a Wyoming Game and Fish road easement in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  aforesaid Section 9, thence N.  $81^{\circ}37'$  W., more or less, a distance of 233.3 feet, more or less; thence S.  $77^{\circ}28'$  W., more or less, a distance of 484.8 feet, more or less, to a point on the east side of the Wyoming Game and Fish Commission parking easement in aforesaid Lot 7, Section 9.
