For and in consideration of one dollar (\$1.00) and other valuable consideration to them paid by Lincoln Service Corporation, the receipt whereof is hereby acknowledged, the undersigned hereby remises, releases and forever discharges the said Lincoln Service Corporation of and from all debts, demands, actions, suits, agreements, damages and any and all claims, demands and liabilities whatsoever of every name and nature, both in law and in equity, which the undersigned now has or ever had from the beginning of the world to this date or shall hereafter acquire as a result of the easement which Lincoln Service Corporation has on the property of the undersigned and for the transmission line erected pursuant thereto or the reasonable servicing and maintenance of the same. Said land being more particularly described as follows, to-wit:

That part of the NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 29., T. 34 N., R. 109W., Sublette County, Wyoming, described as follows: Beginning at Station 118+33.3 on the southwesterly right of way line of the Cora-Pinedale County Road S40°-24' E, 542.0 feet from the northwest corner of said Section 29 where is found a 2" galvanized steel pipe with brass cap inscribed "PAUL N. SCHERBEL RLS164 BIG PINEY WYOMING 1965 T34N R109W S19/S20; thence S39°-49' E, the base bearing for S30/S29

this survey, 170.0 feet along the said right of way line to a point; thence S50°-11' W, 256.3 feet to a point; thence N39°-49' W, 170.0 feet to a point; thence N50°-11' E, 256.3 feet to the place of beginning which is marked by a 2" galvanized steel pipe with brass cap inscribed "PAUL N. SCHERBEL RLS164 BIG PINEY WYOMING 1964 P.C. STA 118+33.3 R/W 40'L; encompassing an area of 1.000 acres, more or less; each point being marked by a steel T-shaped stake 24" long with brass cap inscribed "SURVEY POINT DO NOT DISTURB RLS164"; all in accordance with the map prepared and filed in the Office of the Clerk of Sublette County, Wyoming.
