

that said corporation was duly and regularly dissolved on January 14, 1942, by the filing of Articles of Dissolution with the Secretary of State of the State of Wyoming; that the directors of said corporation acting last before the dissolution thereof were L. C. Nelson, also known as L. G. Nelson, H. Bergen, George M. Bergen and Homer A. France, and that as such directors acting last before the dissolution of said corporation, they became the trustees of said corporation, and of the creditors and stockholders of said corporation, in the dissolution, and distribution of the assets of said corporation.

8. That plaintiffs are now the owners in fee simple, and, under claim of ownership, now are and have been in possession of that certain real property and premises situated, lying and being in the County of Sublette, State of Wyoming, and described as follows, to-wit:

In Township 31 North, Range 107 West of the Sixth Principal Meridian, Sublette County, Wyoming:

Section 2: NE $\frac{1}{4}$ SE $\frac{1}{4}$, S $\frac{1}{2}$ SE $\frac{1}{4}$, S $\frac{1}{2}$ SW $\frac{1}{4}$ and NW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 12: S $\frac{1}{2}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ and SW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 13: NW $\frac{1}{4}$ NW $\frac{1}{4}$, except that portion thereof, and that portion of SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 12 hereinabove described, excepted by L. C. Nelson and Mary Nelson in a Warranty Deed dated March 31, 1950 and recorded January 21, 1954 in the office of the County Clerk of Sublette County, Wyoming in Book 7 of Deeds on Page 348.

In Township 32 North, Range 107 West of the Sixth Principal Meridian, Sublette County, Wyoming:

Section 14: NW $\frac{1}{4}$, SW $\frac{1}{4}$, and Lot 2 (also described as NW $\frac{1}{4}$ NE $\frac{1}{4}$), except that portion of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 14 conveyed to Milford B. Steele by an undated Warranty Deed recorded September 6, 1950 in the office of the County Clerk of Sublette County, Wyoming in Book 6 of Deeds on Page 172.
