KNOW ALL MEN BY THESE PRESENTS, That the Board of Land Commissioners of the State of Wyoming, acting within the authority vested in it by and under the Constitution of the State of Wyoming and the Wyoming Compiled Statutes, doth, for and in consideration of the payment of NONE

(\$ NONE) grant to SUBLETTE COUNTY BOARD OF COMMISSIONERS

for the uses and purposes and upon the conditions hereinafter set forth, an easement for COUNTY ROAD

over a certain tract of land more particularly described as follows:

A strip of land for the Green River Stock Driveway County Road Fifty feet (50') in width, with the easterly line being parallel to and Seventy-five feet (75') westerly of the center line of State Secondary Highway 1802 and the westerly line being parallel to and One Hundred Twenty-five feet (25') westerly of the said center line with the said center line of said Highway, across the Southwest Quarter Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$): Northwest Quarter Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) Section Ten (10); East Half East Half (E $\frac{1}{2}$ E $\frac{1}{2}$) Section Sixteen (16), Township Thirty-four (34) North, Range One Hundred Ten (110) West of the 6th P. M. in Sublette County, Wyoming, being more particularly described as follows:

Beginning at Station 189+19.4 on the south line of the said NW $\frac{1}{4}$ SW $\frac{1}{4}$, N 50° 00' W, 2091 feet from the south one-quarter corner of said Section 10; thence N 01° 22' E, 346.5 feet to Station P. C. 192+65.9; thence Northwesterly, 1146.7 feet along the arc of a 2° curve to the left to Station P. T. 204+12.6; thence N 21° 34' W, 1259.9 feet, more or less, to Station 216+72.5 on the north line of the said SW $\frac{1}{4}$ NW $\frac{1}{4}$; and

Beginning at Station 120+74.5 on the south line of said Section 16, S 89° 19' W, 331.1 feet from the southeast corner of said Section 16; thence N 05° 39' E, 997.6 feet to Station P. C. 130+72.1; thence Northeasterly, 613.3 feet along the arc of a 2° curve to the right to Station P. T. 136+85.4; thence N 17° 55' E, 200.6 feet to Station 138+86.0 on the east line of said Section 16, S 00° 02' E, 788.0 feet from the east one-quarter corner of said Section 16; and
