

RIGHT OF WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of \$1.00, receipt whereof is hereby acknowledged, W. J. GRANSDEN and JANET A. GRANSDEN, husband and wife, of the County of Sublette and State of Wyoming, hereinafter called grantors, hereby grant unto the COUNTY OF SUBLETTE, STATE OF WYOMING, hereinafter called grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across a strip of land 66 feet in width being part of the NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 22; N $\frac{1}{2}$ SE $\frac{1}{4}$ , SW $\frac{1}{4}$ NE $\frac{1}{4}$ , S $\frac{1}{2}$ NW $\frac{1}{4}$ , and NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 21; E $\frac{1}{2}$ NE $\frac{1}{4}$  and E $\frac{1}{2}$ SE $\frac{1}{4}$  of Section 20; N $\frac{1}{2}$ NE $\frac{1}{4}$  and SW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 29, Township 35 North, Range 111 West of the 6th P.M., Sublette County, Wyoming, with the center-line described as follows:
