DESCRIPTION FOR PARADISE COUNTY ROAD FROM

Peter S. Olson, et. ux.

To-wit:

A strip of land one hundred feet in width being part of Lot 4 ($NW\frac{1}{4}NW\frac{1}{4}$) and Lot 3 ($NE\frac{1}{4}NW\frac{1}{4}$) of Section 6, T31N, R108W, Sublette County, Wyoming, with the center-line described as follows:

Beginning at station 441+63.0 on the west line of said Section 6 $S00^{\circ}-31'W$, 770 ft., more or less, from the northwest corner of said Section 6;

thence $N83^{\circ}-41'E$, 19.1 ft. to station 441+82.1;

thence $N66^{\circ}-28'E$, 1137.5 ft. to station 453+19.6;

thence $N80^{\circ}-34'E$, 413.1 ft. to station 457+32.7;

thence $N86^{\circ}-41'E$, 281.5 ft. to station 460+14.2;

thence $N63^{\circ}-03'E$, 207.8 ft., more or less, to station 462+22.0 on the east line of said Lot 3 leaving land of grantor;

thence continuing $N63^{\circ}-03'E$, 240.0 ft., more or less, to station 464+62.0 on the north line of said Section 6, $S89^{\circ}-50'E$, 214.3 ft. from the north one-quarter corner of said Section 6;

and a strip of land one hundred feet in width being part of the $S\frac{1}{2}SE\frac{1}{4}$ of Section 31, T32N, R108W, Sublette County, Wyoming with the center-line described as follows:

Beginning at station 464+62.0 on the south line of said Section 31 $S89^{\circ}-50'E$, 214.3 ft. from the south one-quarter corner of said Section 31;

thence $N63^{\circ}-03'E$, 989.0 ft. to station 474+51.0;

thence $N59^{\circ}-22'E$, 1041.5 ft. to station 484+92.5;

thence $N76^{\circ}-50'E$, 476.2 ft. to station 489+68.7;

thence $N56^{\circ}-16'E$, 135.2 ft. to station 491+03.9;

thence $N41^{\circ}-49'E$, 193.7 ft. to station 492+97.6 at the northeast corner of said

$S\frac{1}{2}SE\frac{1}{4}$; and

a strip of land one hundred feet in width being part of the $N\frac{1}{2}NE\frac{1}{4}$ of Section 17; $SE\frac{1}{4}SE\frac{1}{4}$ of Section 8; and $SW\frac{1}{4}SW\frac{1}{4}$ of Section 9, T32N, R108W, Sublette County, Wyoming with the center-line described as follows:

Beginning at station 693+81.0 on the west line of said $N\frac{1}{2}NE\frac{1}{4}$;

thence $S62^{\circ}-00'E$, 335.8 ft. to station 708+29.8;

thence $N79^{\circ}-17'E$, 361.4 ft. to station 711+91.2;

thence $S88^{\circ}-27'E$, 826.7 ft. to station 720+17.9;

thence $N00^{\circ}-42'E$, 663.7 ft. to station 726+81.6;
