RIGHT OF WAY EASEMENT

Know All Men By These Presents:

That for and in consideration of the sum of Ten (\$10.00)----- dollars, the receipt of which is hereby acknowledged and confessed, Jewett Land and Livestock Company, a Wyoming Corporation

of the County of Sublette----- and the State of Wyoming hereinafter called the grantor, hereby grants to the State of Wyoming, hereinafter called the grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sublette----- and State of Wyoming, to-wit: -----

The location, width of right of way hereby granted is as follows:

A strip of land one hundred feet in width being a part of the SW $\frac{1}{4}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$ and N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 22, T32N, R11W, Sublette County, Wyoming with the center-line described as follows:

Beginning at station 298/00 on the north line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$;
thence S18°-47'W, 637.1 ft. to station 304/37.1;
thence N48°-19'W, 2542.0 ft to station 329/79.1;
thence N21°-52'W, 161.1 ft. to station 331/40.2;
thence N09°-31'W, 163.4 ft. to station 333/03.6 on the north line of the said N $\frac{1}{2}$ SW $\frac{1}{4}$ and leave land of grantor;
thence continuing N09°-31'W, 231.3 ft. to station 335/34.9;
thence N27°-49'W, 748.3 ft. to station 342/83.2;
thence N35°-59'W, 288.4 ft. to station 345/71.6;
thence N56°-39'W, 267.9 ft. to station 348/39.5 on the west line of said Section 22, N00°-02'W, 1240.4 ft. from the west one-quarter corner of said Section 22; all in accordance with the map prepared and filed for record in the Office of the Clerk of Sublette County.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to fence the right of way on both sides with 4 wire fence with posts 16 $\frac{1}{2}$ feet apart, with gates at such points as are necessary. Grantor to maintain fence thereafter. ROAD NOT TO BE FENCED.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irrigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

The grant herein contained is an easement and shall be perpetual so long as said land is used for the aforementioned purposes.
