DECREE OF SETTLEMENT OF ACCOUNT
AND FINAL DISTRIBUTION

Anna Frances Jack the duly appointed Administratrix of the Estate of Robert M. Jack, Deceased, having on the 6 day of May, 1969, rendered and filed herein a full account and report of her administration of said estate, which account was for a final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the Court that the Clerk had given notice of the settlement of said account, and the hearing of said petition in the manner and for the time heretofore ordered and directed by the Court;

And it appearing that said account is in all respects true and correct, and that it is supported by proper vouchers; that since the filing of said account no further assets or funds have been received by the Administratrix; that all claims and debts against said estate are fully paid;

That all taxes on said estate, together with all debts, expenses and charges of administration have been fully paid and discharged, and said estate is ready for distribution and in condition to be closed;

That your Administratrix asks the approval of the payment of attorney fees to her attorneys, Robert L. Bath and Raymond P. Venta in the sum of \$3,765.04.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the final account of the said Anna Frances Jack, Administratrix of the Estate of Robert M. Jack, deceased, be and the same is settled, allowed and approved, and that the residue of said estate hereinafter particularly described and any other property not now known or discovered which may belong to said estate or in which said estate may have an interest, be and the same is hereby distributed as follows, to-wit:

In equal shares to Anna Frances Jack, widow, and Judith Ann Jack, daughter, of said Robert M. Jack, deceased.

IT IS FURTHER ORDERED ADJUDGED AND DECREED that attorney fees to Robert L. Bath and Raymond P. Venta, attorneys for said Administratrix, in the sum of \$3,765.04 be approved and allowed.
