



ORDER AND DECREE ADOPTING PROBATE OF ESTATE IN THE
STATE OF INDIANA AS PROBATE IN THE STATE OF WYOMING

THIS MATTER, coming on regularly to be heard upon the petition filed herein by Joseph H. Galicich, and it appearing to the Court that notice of the hearing on said petition was published and given in the manner and for the time in such cases required by law, and in accordance with the Order Setting Time and Place of Hearing, heretofore made and entered herein; and that no one has appeared to object to, or contest, said petition, and that no objections have been filed thereto;

And the Court, after hearing the evidence offered in support of said petition, and being fully advised in the premises, finds and determines as follows:

1. That James A. Carr, hereinafter referred to as the decedent, died testate at Richmond, in Wayne County, Indiana, on the 25th day of March, 1928; and that at the time of his death he was a resident of Richmond, in Wayne County, State of Indiana;

2. That at the time of his death, the decedent was the owner of the following described property situated in the County of Sublette, State of Wyoming:

The Southwest Quarter of the Northeast Quarter ($SW\frac{1}{4}NE\frac{1}{4}$), the Southeast Quarter of the Northwest Quarter ($SE\frac{1}{4}NW\frac{1}{4}$) and the West Half of the Northwest Quarter ($W\frac{1}{2}NW\frac{1}{4}$) of Section Twenty-five (25), and all of the Northeast Quarter ($NE\frac{1}{4}$) and the Northwest Quarter of the Southeast Quarter ($NW\frac{1}{4}SE\frac{1}{4}$) of Section Twenty-six (26), all in Township Thirty-three (33) North, Range One Hundred Nine (109), West of the Sixth Principal Meridian;

3. That the total value of said property, being all of the property owned by the decedent in the State of Wyoming, did not exceed the sum of Ten Thousand and No/100 (\$10,000.00) Dollars, the value thereof being Two Thousand Seven Hundred and No/100 (\$2,700.00) Dollars; and that although more than one year has elapsed since the death of the decedent, no probate or other proceedings relating to said property have been instituted in the State of Wyoming;

4. That, after due and legal proceedings, the last will and testament of the decedent was admitted to probate in and by the Wayne Circuit Court, 17th Judicial Circuit, within and for Wayne County, State of Indiana, in Probate Proceeding No. 6763, on the 10th day of April, 1928, and Louie W.
