DECREE OF SETTLEMENT OF ACCOUNT
AND FINAL DISTRIBUTION

Dan Radakovich, Administrator of the Estate of George Radakovich, deceased, having on the 3rd day of December, 1970, rendered and filed herein a full account and report of his administration of said estate, which account was for a final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the court that notice of such hearing has been given as required by law;

And it appearing that said account is in all respects true and correct, and that it is supported by proper vouchers and should be confirmed by the Court;

And it appearing that all claims and debts against said decedent, all taxes on said estate have been fully paid and discharged and that the estate is ready for distribution and in condition to be closed;

That there is due and owing the law firm of Venta, Bath & Murray, attorneys at law, attorney fees in the statutory amount of \$215.00, which should be approved and allowed by the Court;

That the said George Radakovich, deceased, died intestate in the County of Sweetwater, State of Wyoming, on the 30th day of June, 1970, leaving surviving him the said Dan Radakovich, son, age 27; Don Radakovich, son, age 27; Stevie Radakovich, son, age 22, and Sherrie Kay Radakovich, daughter, age 13. That said children are each entitled to 1/4 of the residue of said estate;

That the said Dan Radakovich has been appointed by this Court and is the acting guardian of the estate and person of the said Sherrie Kay Radakovich;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that said final account of the said Dan Radakovich, Administrator be and the same is settled, allowed and approved, and that attorney fees in the sum of \$215.00 to the law firm of Venta, Bath & Murray of Rock Springs, Wyoming, are approved and allowed.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the residue of said estate hereinafter particularly described, and other property not now known or discovered which may belong to said estate, or in which the said estate may have any interest, be and the same is hereby distributed as follows, to-wit:

to the said Dan Radakovich, 1/4 share
 to the said Don Radakovich, 1/4 share
 to the said Stevie Radakovich, 1/4 share
 to the said Sherrie Kay Radakovich, 1/4 share

providing, however, all personal property of Sherrie Kay Radakovich may be distributed to Dan Radakovich as the acting Guardian of the estate and person of Sherrie Kay Radakovich.
