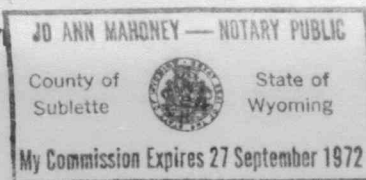

Beginning at a point East, 100.0 feet from the southwest corner of the Cooley First Addition to the Town of Pinedale of record in Book 10 of Miscellaneous on page 50 in the Office of the Clerk of Sublette County, S36°-30'E, 1299.4 feet from the northwest corner of said Section 3; thence South, 7200 feet along the east line of the Hagenstein Addition and Nelson Addition to the Town of Pinedale to the southeast corner of said Nelson Addition; thence East, 360.0 feet along a line protracted from the south line of "B" Street of the said Nelson Addition; thence North, 1410.0 feet to a point on the south line of the said Cooley First Addition identical with the center-line of Mill Street; thence West, 40.0 feet along the said center-line to a corner of the said Cooley First Addition; thence South, 690.0 feet along the east line of said Cooley First Addition identical with the center-line of Bridger Avenue to the southeast corner of said Addition; thence West, 320.0 feet along the south line of said Addition to the point of beginning; encompassing an area of 6.584 acres, more or less

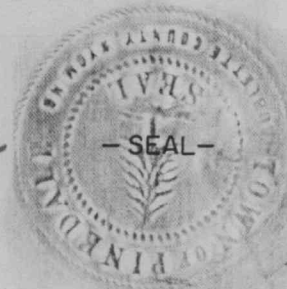
