DECREE OF FINAL SETTLEMENT OF ACCOUNT
AND ORDER OF DISTRIBUTION

Rudolph D. Magagna, executor of the last will and testament of Fred L. Magagna, also known as Alfred L. Magagna, deceased, having on the 5th day of July, 1972, rendered and filed herein a full account and report of his administration of said estate, which account was for a final settlement, and having with said account filed a petition for the distribution of the residue of said estate;

And the said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the Court that notice of the settlement of said account and the hearing of said petition has been given in the manner and for the time in such cases required by law;

And it appearing that said account is in all respects true and correct; that all notices have been published in the manner and for the period required by law; that all claims and debts against said decedent, all taxes against said estate, including federal estate taxes and all inheritance taxes due the State of Wyoming, and all expenses and charges of administration with the exception of the fees of the executor and the attorneys for the estate, recording fees and the cost of transferring the hereinafter described corporate stocks, have been paid and discharged; and that said estate is now ready for distribution and in condition to be closed;

And it further appearing that since the filing of said final account and petition for distribution, the executor has collected certain additional amounts and has made certain payments for and in behalf of the estate, all as-is set forth in the supplemental accounting this day filed herein, and that said supplemental accounting is in all respects true and correct;

And it further appearing that after the payment of the fees of the executor and the attorneys, which have this day been set by a separate order of this Court, the following is all of the residue and remainder of said estate:
