

An undivided one-half interest in and to promissory note, dated October 2, 1967, executed by Clarence Boss and Lorraine Boss in favor of John Anselmi and Fred L. Magagna, in the principal amount of \$28,000.00 and bearing interest at the rate of 8% per annum from October 27, 1969, said interest and principal being payable \$377.60 on November 1, 1969, and \$377.60 on the 1st day of each and every month thereafter until said principal and interest are fully paid, which promissory note is secured by a mortgage, dated October 27, 1969, made, executed and delivered by Edward G. Shineberg and Elisabeth J. Shineberg, husband and wife, in favor of John Anselmi and Fred L. Magagna, in the principal amount of \$28,000.00, covering the following described real property:

All that portion of Lots 9 and 10, Block 8 of the Original Town of Rock Springs, Sweetwater County, State of Wyoming, more particularly described as follows:
