A G R E E M E N T

THIS AGREEMENT, Made and entered into this 1st day of August, 1972, by and between J. WILLIAM BLOOM, aka WILLIAM BLOOM, aka BILL BLOOM and MAGDALINE BLOOM, husband and wife, of Pinedale, Wyoming, hereinafter referred to as the "Sellers" and JOHN A. DUSSAULT and DOROTHY B. DUSSAULT, husband and wife of Pinedale, Wyoming, hereinafter referred to as the "Buyers".

W I T N E S S E T H :

WHEREAS, the Sellers are the owners of certain real property located in Sublette County, Wyoming; and

WHEREAS, the Buyers desire to purchase said real property and the Sellers are desirous of selling the same:

NOW, THEREFORE, IT IS MUTUALLY AGREED THAT:

ARTICLE I

The Buyers shall buy, and the Sellers shall sell, grant and convey to the Buyers by good and sufficient Warranty Deed, all of the following described real property, including the release and waiver of all rights of homestead, free and clear of all encumbrances:

2. That part of Lot 1 of Section 6; and of Lot 4, Section 5, T. 33 N. R. 109 W., containing 20.483 acres, being the Bloom Subdivision; and

3. A parcel of land in the NE $\frac{1}{4}$ Section 4, T. 33 N., R. 109 W., 6th P.
