

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

1. That the Final Account and Report as filed herein by said Executor, be, and it is hereby allowed, settled, ratified and confirmed and in all ways approved.

2. That said Executor be and he is hereby authorized and directed to pay the presently unpaid administrative expenses, costs and charges.
