That the deceased, Bud N. Fackrell, is one and the same person as the said Bud N. Fackrell, one of the Buyers in the beforementioned Real Estate Sale Agreement; that the affiant, Bernita E. Fackrell, is one and the same person as the Bernita E. Fackrell, the other Buyer in said Real Estate Sale Agreement.

That on the 20th day of February, 1966, and many years before that date, and until his demise, the said Bud N. Fackrell and the said Bernita E. Fackrell were husband and wife, and that the before mentioned Real Estate Sale Agreement created an estate by the entireties, under the laws and the Supreme Court decision of the State of Wyoming, and at the death of Bud N.
