and mortgaged.

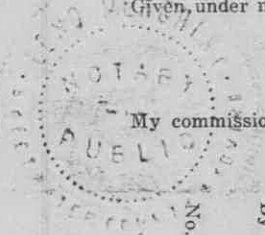
