Beginning at the southwest corner of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section Twenty-one (21), Township Thirty-eight North (38N) Range One Hundred Thirteen (113) West of the Sixth Principal Meridian, running in a northerly direction 300 feet to a point on the westerly line of said Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section Twenty-one (21), Township Thirty-eight (38) North, Range One Hundred Thirteen (113) West of the Sixth Principal Meridian; thence at right angles in an easterly direction 200 feet to a point; thence at right angles in a southerly direction 300 feet to a point; thence at right angles in a westerly direction 200 feet to the point of beginning, together with all buildings, improvements, and appurtenances situate thereon and appertaining thereto, and any and all water rights appertaining thereto. Also an Easement for a right-of-way, four rods wide, along the west line of the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of Section Twenty-one (21) Township Thirty-eight North (38N), Range One Hundred Thirteen (113) West of the Sixth Principal Meridian, situate in the County of Sublette, State of Wyoming,
