Beginning at the north quarter-section corner of said Section 26; running thence South 1° 56' West, along the west line of the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of said Section 26, 146.2 feet; thence South 74° 48' East, 374.9 feet; thence North 15° 12' East, 498.92 feet; thence North 74° 48' West, 499.06 feet to the west line of the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of said Section 23; thence South 0° 56' West, 367.97 feet to the point of beginning, containing 4.994 acres, and all corners of said parcel being marked by a 3/4" steel T-bar driven in the ground, topped with a steel identification cap inscribed "RLS 641."
