

Partial Release

This Indenture Witnesseth, That *The Travelers Insurance Company*, a corporation organized and existing under the laws of the State of Connecticut, for the consideration of one dollar and other valuable consideration Dollars, does hereby Release and Quit-Claim unto

Robert W. Wilson and Ruth E. Wilson, husband and wife,

of Sublette County and State of Wyoming all its right, title, and interest in and to the following described Real Estate, situate in the County of Sublette and State of Wyoming, to wit:
