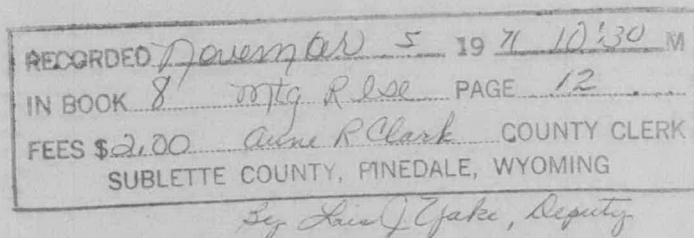


KNOW ALL MEN BY THESE PRESENTS, That Western National Bank of Lovell
