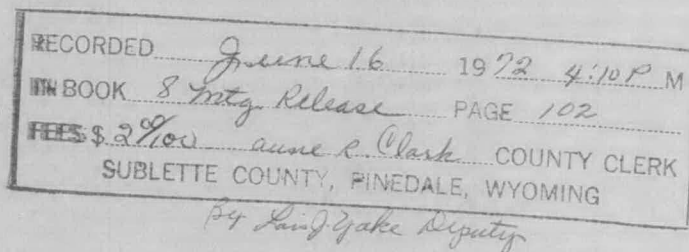


KNOW ALL MEN BY THESE PRESENTS, That First National Bank of Pinedale


