

PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS THAT The Jackson State Bank, A Wyoming Banking Corporation, mortgagee, named in a certain mortgage given by Edward H. Beginning at a point which lies N. $45^{\circ}22'25''$ E, 456.2 feet and N $16^{\circ}47'25''$ E, 360.0 feet from the corner common to Sections 20/21, Sections 29/28;

Thence N $16^{\circ}47'25''$ E, a distance of 654.80 feet;
 Thence S. $87^{\circ}51'25''$ W, a distance of 112.60 feet;
 Thence S. $64^{\circ}21'25''$ W, a distance of 145.70 feet;
 Thence S. $48^{\circ}55'25''$ W, a distance of 481.30 feet;
 Thence S. $0^{\circ}43'25''$ W, a distance of 169.00 feet;
 Thence S. $79^{\circ}57'2''$ E, a distance of 426.25 feet to the point of beginning, said parcel of land containing 5.03 acres more or less.

It being expressly understood and agreed that this release shall not affect the said mortgage or the security thereof, in any manner or form whatsoever, as to the remainder of the real estate mortgaged therein and thereby.
