This article of agreement made and entered into this 7th day of May, 1930, by and between D. O. Willey, Jr., of Salt Lake City, Utah, party of the first part, I. E. Willey, also of Salt Lake City, party of the second part, and Midvale Oil Corporation, a Nevada corporation, party of the third part, (hereinafter, for brevity, referred to as Midvale Corporation), witnesseth:

Whereas, on the 6th day of May, A. D. 1926, a drilling contract was entered into between one Garland P. Fallis and the said D. O. Willey, Jr., he being the permittee named in Permit Serial Number 07671 covering all of Section 8 in Township 27 North, Range 113 West of the Sixth Principal Meridian, Sublette County, Wyoming, a copy of which contract is attached hereto and by this reference made a part hereof to the same force and effect as if it, together with the signatures thereto, were set forth at length as a part of this paragraph; and

Whereas, on the 7th day of May, A. D. 1926, a certain written contract was entered into by and between the said Garland P. Fallis and the above named I. E. Willey, wherein for a consideration therein named the said Garland P. Fallis covenanted and agreed to reserve and did reserve for the use and benefit of the said I. E. Willey 20 acres to be hereafter selected by the said I. E. Willey out of that portion of said land above described which might be, under the rules and regulations of the Department of the Interior, and of the law relating thereto, designated and selected by said permittee and said Garland P. Fallis as preference land, and also forty acres of said above described land to be selected by said Garland P. Fallis outside of and in addition to the land to be selected as preference land, subject to the five per cent royalty as hereinbefore described, said contract having been duly filed for record in the office of the County Clerk and Ex-officio Register of Deeds of Sublette County, Wyoming, and appearing of record at page 413 of Book 1, Miscellaneous Records of said County, on the 27th day of May, 1926, which contract is hereto, by this reference, made a part hereof to the same force and effect as if it were set forth at length in this paragraph; and

Whereas, said contract between said D. O. Willey and said Garland P. Fallis, and all rights thereunder of the said Garland P. Fallis, were assigned to the said Midvale Oil Corporation on the 14th day of May, 1926, by which assignment the said Midvale Oil Corporation acquired all the interest of said Garland P. Fallis in and under said contract, and assumed all obligations and agreements therein assumed and agreed to by the said Garland P. Fallis; and
