PARTIAL ASSIGNMENT OF OIL AND GAS LEASE

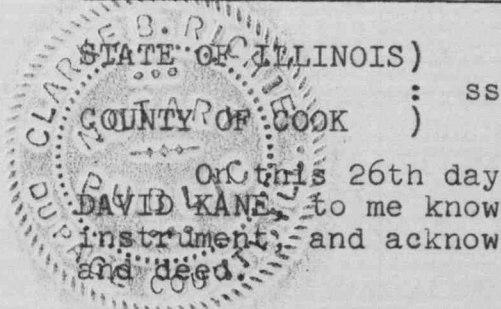
