KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, by Assignment dated August 1, 1951, G. W. Anderson and Ida Lee Anderson, husband and wife, have heretofore sold and assigned to Shell Oil Company, a Delaware corporation, Los Angeles, California, all those certain oil and gas leases described as follows:

1. Oil and Gas Lease dated May 26, 1951, by and between John Schneider and Erika L. Schneider, husband and wife, as Lessors, and G. W. Anderson, Lessee, 509 Atlas Building, Salt Lake City, Utah, said lease being of record in the office of the County Clerk of Sublette County, Wyoming, in Book 2 of Oil and Gas Leases on page 461.

Anderson and Ida Lee Anderson, husband and wife, excepted and reserved unto themselves an overriding royalty of five per cent (5%) of all oil, gas and other hydrocarbon substances produced, saved and marketed from lands covered by each and every of said respective Oil and Gas Leases as said lands and Oil and Gas Leases are above described.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00), receipt of which is hereby acknowledged, the said G. W. Anderson and Ida Lee Anderson, husband and wife, do hereby sell, assign, transfer and convey an overriding royalty of one per cent (1%) to Beverley Lasrich, an overriding royalty of one-fifth of one per cent (1/5 of 1%) to Lawrence M.
