

ASSIGNMENT OF AGREEMENT  
AND OPTION

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, the undersigned JUSTHEIM PETROLEUM CORP., a Nevada Corporation, of 212 Phillips Petroleum Bldg., Salt Lake City, Utah, hereinafter called Assignor, is the owner and holder of an agreement and option dated the 22nd day of September 1952, ~~1953~~, executed by John A. WHEREAS, the said optionor excepted and reserved an overriding royalty of 3% (percent) on all oil and gas produced, saved and marketed from the above described lands:

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable considerations to the undersigned assignor in hand paid by Charles Getzler, hereinafter called assignee, the receipt of which is hereby confessed and acknowledged, the said assignor does hereby assign, grant, bargain, transfer and set over unto said assignee, its successors and assigns, the above described agreement and option, together with all of assignor's right, title and interest in and to said agreement and option, subject only to the following:

- A. The aforesaid overriding royalty of Three percent ( 3% ) so reserved to the said optionor.
- B. An additional overriding royalty of Three percent ( 3% ) on all oil and gas produced, saved and marketed from the above described lands reserved hereunder to and by the said assignor.
