which said Oil and Gas Lease was recorded October 27, 1948 in Book 2 of Oil and Gas Leases, page 179, of the records of Sublette County, State of Wyoming, and

WHEREAS, the aforesaid Oil and Gas Lease provides that the same shall continue for a term of five (5) years from its date and as long thereafter as oil or gas, or either of them, is produced from said land by the lessee, and lessors have agreed to extend and continue said Lease for the additional period herein-after specified beyond said primary term of five (5) years,

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, in hand paid by the lessee and assigns, the receipt whereof is hereby acknowledged, lessors hereby acknowledge satisfaction of the provisions of the first paragraph of Section numbered 4 of said Lease, and ratify and confirm said Lease as in full force and effect, and further do hereby extend the primary term of said Lease an additional period of one year from and after the expiration of the presently stated five-year primary term of said Lease, subject, however, to all of the other terms and conditions of said Lease as so extended.
