KNOW ALL MEN BY THESE PRESENTS that:

WHEREAS, under date of April 27, 1948, Robert L. Miller and Mildred M. Miller, his wife, as lessors, executed and delivered to J. H. Morgan and C. I. Justheim an Oil and Gas Lease which was recorded October 27, 1948 in Book 2, Oil and Gas Leases, page 175, Records of Sublette County, Wyoming, and

WHEREAS, under date of June 16, 1950, said J. H. Morgan and C. I. Justheim assigned to Birgit K. Preston and David Kane said Oil and Gas Lease as to a portion of the lands covered thereby, said assignment having been recorded in Book 4, Oil and Gas Leases, page 219, Records of Sublette County, Wyoming, and

WHEREAS, under date of August 26, 1952, said Birgit K. Preston and said David Kane executed and delivered to the undersigned, Robt. W. Atha, a "Partial Assignment of Oil and Gas Lease", covering a portion of the lands assigned to them as aforesaid under date of June 16, 1950, said "Partial Assignment of Oil and Gas Lease" having been recorded in Book 4, Oil and Gas Leases, page 237, Records of said County, and

WHEREAS, by an instrument captioned "Agreement" and dated August 7, 1952, said Lessors, Robert L. Miller and Mildred N. Miller, agreed, upon request of said Robt. W. Atha or his assigns, to execute and deliver an instrument ratifying and confirming said Oil and Gas Lease as being in full force and effect and extending the primary term thereof for the additional period of one year from and after the expiration of the original five-year primary term of said Oil and Gas Lease.

PRESTON and DAVID KANE all and whatsoever the right, title, and interest in, to and under said Lease acquired by him under and by virtue of the above mentioned "Partial Assignment of Oil and Gas Lease", dated August 26, 1952, and also all and whatsoever his rights under and by virtue of the above mentioned "Agreement" of August 7, 1952.
