KNOW ALL MEN BY THESE PRESENTS that:

WHEREAS, under date of April 28, 1948 Bar Cross Land and Livestock Company, a Wyoming Corporation, as Lessor, executed and delivered to J. H. Morgan and C. I. Justheim an Oil and Gas Lease which was recorded October 27, 1948 in Book 2, Oil and Gas Leases, page 183, Records of Sublette County, Wyoming, and

WHEREAS, under date of June 16, 1950 said J. H. Morgan and C. I. Justheim assigned to Birgit K. Preston and David Kane, said Oil and Gas Lease as to the portion of land covered thereby, said assignment having been recorded August 6, 1952 in Book 4, Oil and Gas Leases, page 223, Records of Sublette County, Wyoming, and

WHEREAS, under date of August 26, 1952 said Birgit K. Preston and said David Kane executed and delivered to the undersigned, Robt. W. Atha, a "Partial Assignment of Oil and Gas Lease", covering a portion of the lands assigned to them as aforesaid under date of June 16, 1950, said "Partial Assignment of Oil and Gas Lease" having been recorded September 19, 1952 in Book 4, Oil and Gas Leases, page 241, Records of Sublette County, Wyoming, and

WHEREAS, by an instrument captioned "Extension of Oil and Gas Lease", acknowledged March 19, 1953, said Lessor, Bar Cross Land and Livestock Company, of Wyoming Corporation, extended the primary term of said Oil and Gas Lease for a period of one year from and after the expiration of the original five-year primary term of said Oil and Gas Lease.

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good, sufficient and acknowledged consideration, said Robt. W. Atha does hereby sell, assign, transfer and set over to said Birgit K. Preston and David Kane all and whatsoever the right, title and interest in, to and under said Lease as acquired by him under and by virtue of the above mentioned "Partial Assignment of Oil and Gas Lease", dated August 26, 1952, including all and whatsoever rights accruing or to accrue to him under and by virtue of the above mentioned "Extension of Oil and Gas Lease" acknowledged March 19, 1953.
