PARTIAL ASSIGNMENT OF OIL & GAS LEASE

KNOW ALL MEN BY THESE PRESENTS that,

WHEREAS, under date of April 27, 1948, Robert L. Miller and Mildred M. Miller as Lessors, issued an oil and gas lease to J.H. Morgan and C.I. Justheim, said instrument recorded October 27, 1948 in Book 2, Oil and Gas Leases, Page 175, Sublette County, Wyo., and

WHEREAS, under date of August 4, 1952, J.H. Morgan and C.I. Justheim assigned to E.J. Preston said oil and gas lease, as to a portion of the land covered thereby, said assignment recorded August 6, 1952 in Book 4, Oil and Gas Leases, Page 221, Sublette County, Wyo., and

WHEREAS, under date of August 26, 1952, E.J. Preston assigned to Robt. W. Atha the following described land from that assigned to him under date of August 4, 1952, said instrument recorded September 19, 1952 in Book 4, Oil and Gas Leases, Page 235, Sublette County, Wyo:


WHEREAS, under date of April 20, 1953, Robt. W. Atha reassigned to E.J. Preston all of his right, title and interest in and to said lease, insofar as it covers the above described land, and other land assigned to him under date of August 26, 1952, said instrument recorded June 19, 1953 in Book 5, Oil and Gas Leases, Page 274, Sublette County, Wyoming.

NOW THEREFORE, in consideration of \$10.00 and other good and valuable consideration, receipt of which is hereby acknowledged, the undersigned E. J. PRESTON does hereby sell, assign, transfer and set over unto J.H. MORGAN SR. and C.I. JUSTHEIM all of his right, title and interest in and to said lease, insofar as said lease refers to the above described land, subject to an overriding royalty unto J.H. Morgan and C.I. Justheim aggregating 3% reserved under assignment of August 4, 1952.

Also reserving unto E.J. Preston and David Kane a One and one-half percent (1 1/2%) overriding royalty of all oil and/or gas or other hydrocarbons produced, saved and sold from all of the above described land, EXCLUDING SE 1/4 SE 1/4 Sec. 32, Tw. 30 North, Range 112 West.

Said royalty payments shall be paid at the time and subject to the same conditions as royalty payments are made to the lessors.


