WHEREAS, the aforesaid Oil and Gas Lease provides that the same shall continue for a term of five (5) years from its date and as long thereafter as oil or gas or casinghead gas or either of them is produced therefrom by the lessees, and lessors have extended and continued said lease to April 27, 1954, beyond said primary term of five years.

NOW, THEREFORE, in consideration of ONE AND NO/100 Dollars, (\$ 1.00), and other good and valuable consideration in hand paid by the lessees and assigns, receipt of which is hereby acknowledged, lessors hereby ratify and confirm said lease as in full force and effect; and further do hereby extend the primary term of said lease an additional period of one (1) year ^{from} and after April 27, 1954, subject however, to all the other terms and conditions of said lease as so extended.
