NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, J. H. Morgan and C. I. Justheim, does hereby set over, transfer and assign unto Selma Ruben, 110 Ocean Parkway, Brooklyn, N. Y.

subject to the approval of the Secretary of the Interior, and undivided 0.1 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease, divided as follows:
