ASSIGNMENT OF ROYALTY INTEREST

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, under date of December 1, 1950, the United States of America issued unto J. H. Morgan and C. I. Justheim, as Lessee, that certain U. S. Oil and Gas Lease bearing Serial No. Ev. 024628(A), affecting certain lands in the County of Sublette, State of Wyoming, described as follows:

WHEREAS, J. H. Morgan and C. I. Justheim are the present owners and holders of a 0.1 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the said lands, under and pursuant to said Oil and Gas Lease.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, J. H. Morgan and C. I. Justheim, do hereby set over, transfer and assign unto Selma Ruben, 110 Ocean Parkway, Brooklyn, N. Y. subject to the approval of the Secretary of the Interior, and undivided 0.1 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease, divided as follows:

This Assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
