WHEREAS, pursuant to an Assignment of Overriding Royalty dated March 25, 1953 from Northern Pump Company to the undersigned Assignor, the undersigned is the present owner and holder of a one per cent (1%) overriding royalty interest in the above described lands.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned Assignor does hereby sell, assign and transfer to C. I. Justheim and J. H. Morgan, Sr. one-half of one per cent ($\frac{1}{2}$ of 1%) royalty interest in and to all oil and/or gas produced, saved and sold from the above described lease. Said royalty payments are to be made and paid at the time and under the same terms and conditions as payments are made to the Assignor.

This Assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
