This agreement between Joe L. Budd and Arthur B. Belfer, president of Belco Corporation, concerning the following three leases:-

2. Lease dated May 25, 1953, between John C. Budd and Lulu A. Budd, Joe L. Budd, Ruth F. Budd and Clarence I. Justheim, covering certain lands in Sections 27,28,34 and 35 of T. 31N., R. 112W., and Sections 2 and 3 of T. 30N., R. 112 W., and
3. Lease dated October 9, 1952 between John C. Budd, John C. Budd and Son, Joe L. Budd, Ruth F. Budd, and Lulu A. Budd, and Clarence I. Justheim and J. H. Morgan, Sr.,

which three leases carry a single well drilling commitment on one of the three leases, and which three leases have been assigned to Arthur B. Belfer or Belco Petroleum Corporation;

it is agreed herewith that the time limit of the drilling commitment, which is attached as a rider to the No. 1 lease above, be extended from July 1, 1954 to August 31, 1954.
