ASSIGNMENT

THIS INDENTURE, made this 16th day of July, 1945, by and between North LaBarge Oil Company, a Wyoming Corporation, party of the first part, and Western Oil Refining Company, a Wyoming Corporation, party of the second part:

WHEREAS, party of the first part did, on the 26th day of December, 1941, being then the owner of the rights and interests herein-after described, convey and assign the same to Wasatch Production Company, and

WHEREAS, by instrument bearing date the 17th day of August, 1943, said Wasatch Production Company did reconvey and reassign to party of the first part, the said rights and interests, and

WHEREAS, pursuant to a resolution and direction of the stockholders of party of the first part, passed and adopted at a special meeting of said stockholders on the 22nd day of July, 1944, party of the first part did advertise for sale at public auction and did, on May 15, 1945, at such public auction, strike off and sell to party of the second part, for the sum of Twenty-two Thousand Five Hundred and No/100 (\$22,500.00) Dollars cash, the said rights and interests, and

WHEREAS, at a special meeting of the Board of Directors of party of the first part, duly called and held on the 25th day of June, 1945, a resolution was passed and adopted by said Board of Directors, confirming and approving such sale and directing the officers of party of the first part to execute good and sufficient conveyances of said rights and interests to party of the second part,

NOW THEREFORE, THIS INDENTURE,

WITNESSETH:

THAT the said party of the first part, for and in consideration of the said sum of Twenty-two Thousand Five Hundred and NO/100 (\$22,500.00) Dollars, to it in hand paid by party of the second part, receipt whereof is hereby confessed and acknowledged, and in further consideration of the royalties hereinafter mentioned and reserved, does by these presents sell, assign, convey and quit claim unto the said party of the second part, its successors and assigns, the rights and interests described as follows:

1. Operating agreement covering Fred J. Hischier Lease, Evanston 021979, embracing  $W\frac{1}{2}SE\frac{1}{4}$ ,  $E\frac{1}{2}SW\frac{1}{4}$ ,  $NW\frac{1}{4}SW\frac{1}{4}$ ,  $S\frac{1}{2}NW\frac{1}{4}$ ,  $NW\frac{1}{4}NW\frac{1}{4}$  (Lot 4), Section 4;  $W\frac{1}{2}NE\frac{1}{4}$ , Section 9, all in Township 27 North, Range 113 West, containing 400 acres, and being subject to royalties to Hischier and others.
2. Operating agreement from Calmonica Petroleum Corporation, embracing part of Oil and Gas Lease, Evanston 09561-b, covering the following lands:  $W\frac{1}{2}NW\frac{1}{4}$ , Section 17, Township 27 North, Range 113 West, containing 80 acres, subject to royalty to Calmonica Petroleum Corporation and others.
3. Operating agreement covering part of H. A. Lewis Lease, Evanston 07538, covering the following described lands:  $N\frac{1}{2}, N\frac{1}{2}S\frac{1}{2}$ , Section 5, Township 27 North, Range 113 West, and  $E\frac{1}{2}SE\frac{1}{4}$ ,  $NE\frac{1}{4}$ , Section 32,  $NW\frac{1}{4}$  Section 33, Township 28 North,
